Special power of attorney (litigation, receipt of dues, completion of transactions, vehicles, commercial licenses, real property, shares, signature authorization)			
Cancellation of POAs (this is only available for POAs which we previously notarized)		AED 100	AED 500 + Tax
Providing a True Copy of a notarized documents (this is only available for documents which we previously notarized)		AED 5 for each paper	AED 100 + Tax

Moving	Fees
<b>Moving of the notary to draft or notarize contracts, powers of attorney or documents outside his office</b>	
During the official working hours (only in the capital, not in the affiliated areas).	AED 2000 + Tax
Moving to notarize transactions in the areas affiliated to the Emirate of Abu Dhabi.	AED 3000 + Tax
If the notary moves to more than one place to complete the same transaction, moving fees of AED (300) shall be imposed every time.	
Other services (notarizations from official bodies / Ministry of Foreign Affairs / Embassy / Ministry of Justice).	AED 1000 + Tax
